

RESOLUTION NO. _____

A RESOLUTION AUTHORIZING THE NORTH LITTLE ROCK POLICE DEPARTMENT TO DONATE CERTAIN USED EQUIPMENT TO THE JERICHO POLICE DEPARTMENT; AND FOR OTHER PURPOSES.

WHEREAS, the North Little Rock Police Department has replaced certain equipment and has several items that will no longer be used by the department; and

WHEREAS, the Jericho Police Department has expressed a need for the used equipment (see Exhibit "A" attached hereto); and

WHEREAS, pursuant to Ark. Code Ann. § 14-52-113 a municipal police department may exchange personal property with another municipal police department.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF NORTH LITTLE ROCK, ARKANSAS:

SECTION 1: That the North Little Rock Police Department is hereby authorized to donate the following used equipment to the Jericho Police Department:

- 2 Vehicle Cages
- 2 Federal Signal Smart Sirens with Speakers
- 4 Federal Signal Smart Sirens with Speakers
- 4 Switcher Boxes
- 1 Half Consol with Floor Mount
- Ballistic Vests

SECTION 2: That the donation of the equipment described in Section 1 above shall be made pursuant to the following conditions:

- (a) The Jericho Police Department will acknowledge that the equipment is *used* and is beyond the recommended use time by the manufacturer.
- (b) The City of North Little Rock Police Department or any of its agents or officers do not offer any warranty on the used equipment, express or implied.
- (c) The Jericho Police Department will retain ownership of the used equipment and will assume all liability for its use until such time as it is destroyed and made totally unusable.

SECTION 3: That this Resolution shall be in full force and effect from and after its passage and approval.

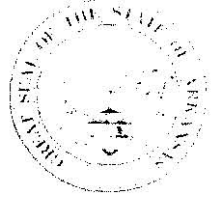

RE: Police Department Equipment


