

ORDINANCE NO. ____

AN ORDINANCE ALLOWING A SPECIAL USE FOR MULTIPLE USES IN A C-6 ZONE FOR CERTAIN REAL PROPERTY LOCATED AT 500 NORTH MAGNOLIA STREET IN THE CITY OF NORTH LITTLE ROCK, ARKANSAS; DECLARING AN EMERGENCY; AND FOR OTHER PURPOSES.

WHEREAS, application was duly made by Collins Development Company, LLC/Collins Revocable Family Trust, 218 West 6th Street, North Little Rock, Arkansas 72114, seeking a special use of said land, which application was duly considered and approved (7 affirmative votes, 2 absent) by the North Little Rock Planning Commission at a regularly scheduled meeting thereof, held on May 14, 2019.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NORTH LITTLE ROCK, ARKANSAS:

SECTION 1. That a special use is granted for multiple uses in a C-6 zone for the subject real property being more particularly described as:

Lot 6, Block 33, Argenta Addition, City of North Little Rock, Pulaski County, Arkansas (See maps attached hereto collectively as Exhibit A.)

SECTION 2. That this special use shall be subject to the following conditions:

1. No outdoor storage materials.
2. Allow an indoor recreation (e.g. axe throwing) business.
3. Hours of operation for indoor recreation (e.g. axe throwing): Monday – Saturday, 9:00 a.m. to 11:00 p.m.; Sunday 12:00 p.m. to 8:00 p.m.
4. No barbwire permitted.
5. If a commercial dumpster is utilized, the location is to be approved by the Design Review Committee.
6. Provide 2 street trees along North Magnolia that are 2.5’ caliper at waist high.
7. Allow commercial vehicle parking within the existing fenced area.
8. Any structures located on the lot shall meet all applicable Federal, State, County, and City requirements and codes.
9. Business license to be issued after Planning Staff confirmation of requirements.
10. Applicant/owner understands that failure to comply with these conditions may result in loss of the Special Use and/or loss of Business License and/or removal of Electric Power Meter.

SECTION 3. That all ordinances or parts of ordinances in conflict herewith are hereby repealed to the extent of the conflict.

SECTION 4. That the provisions of this Ordinance are hereby declared to be severable and if any section, phrase or provision shall be declared or held invalid, such invalidity shall not affect the remainder of the sections, phrases or provisions.

SECTION 5. It is hereby found and determined that the special use of the above-described lands as provided for herein is immediately necessary in order to insure the proper and orderly growth of this land and the proper and orderly growth of the City of North Little Rock, Arkansas, and being necessary for the immediate preservation of the public health, safety and welfare, THEREFORE, an emergency is hereby declared to exist and this Ordinance shall be in full force and effect on the date set forth below.

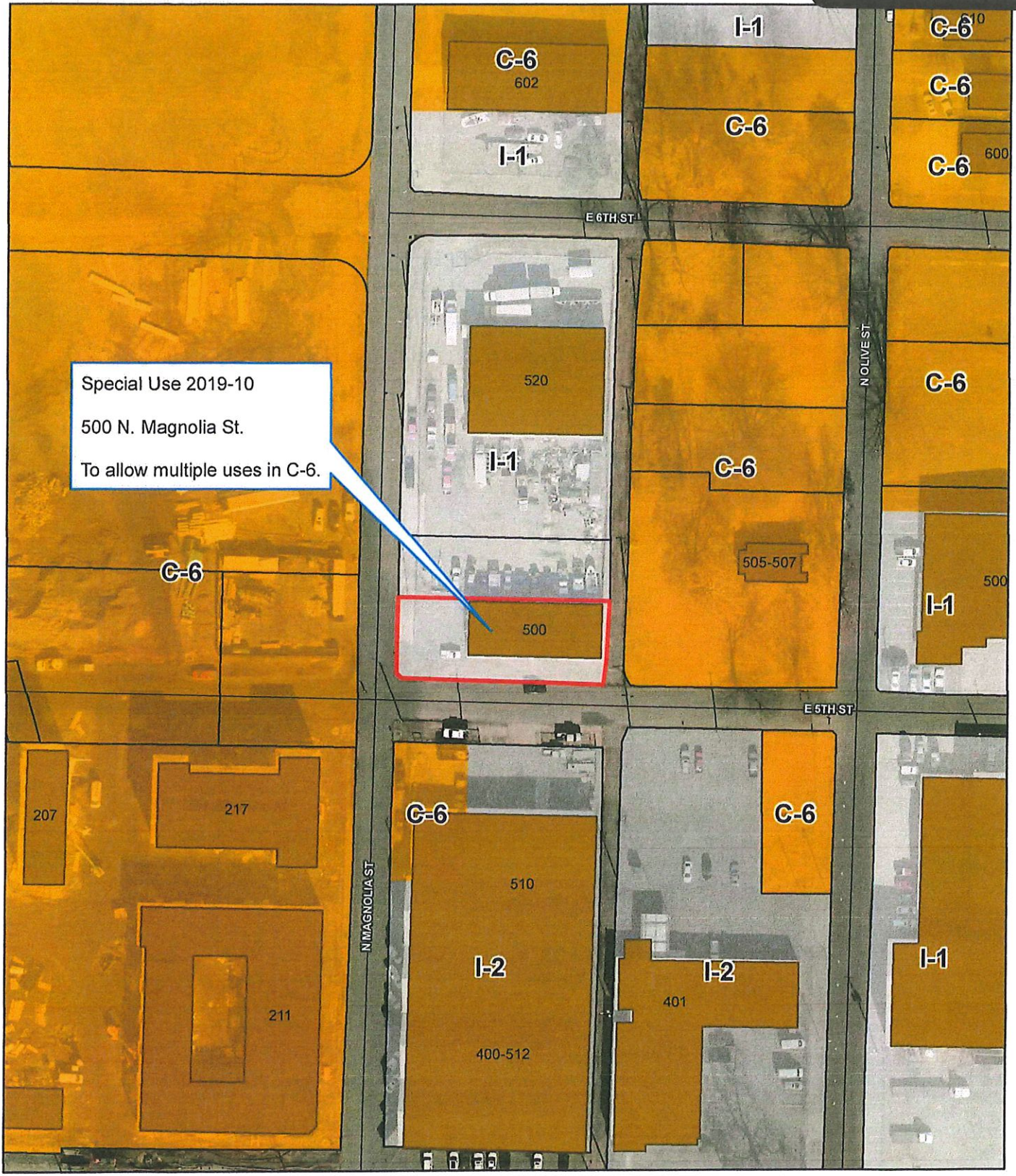

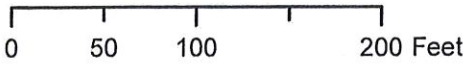

Zoning Map

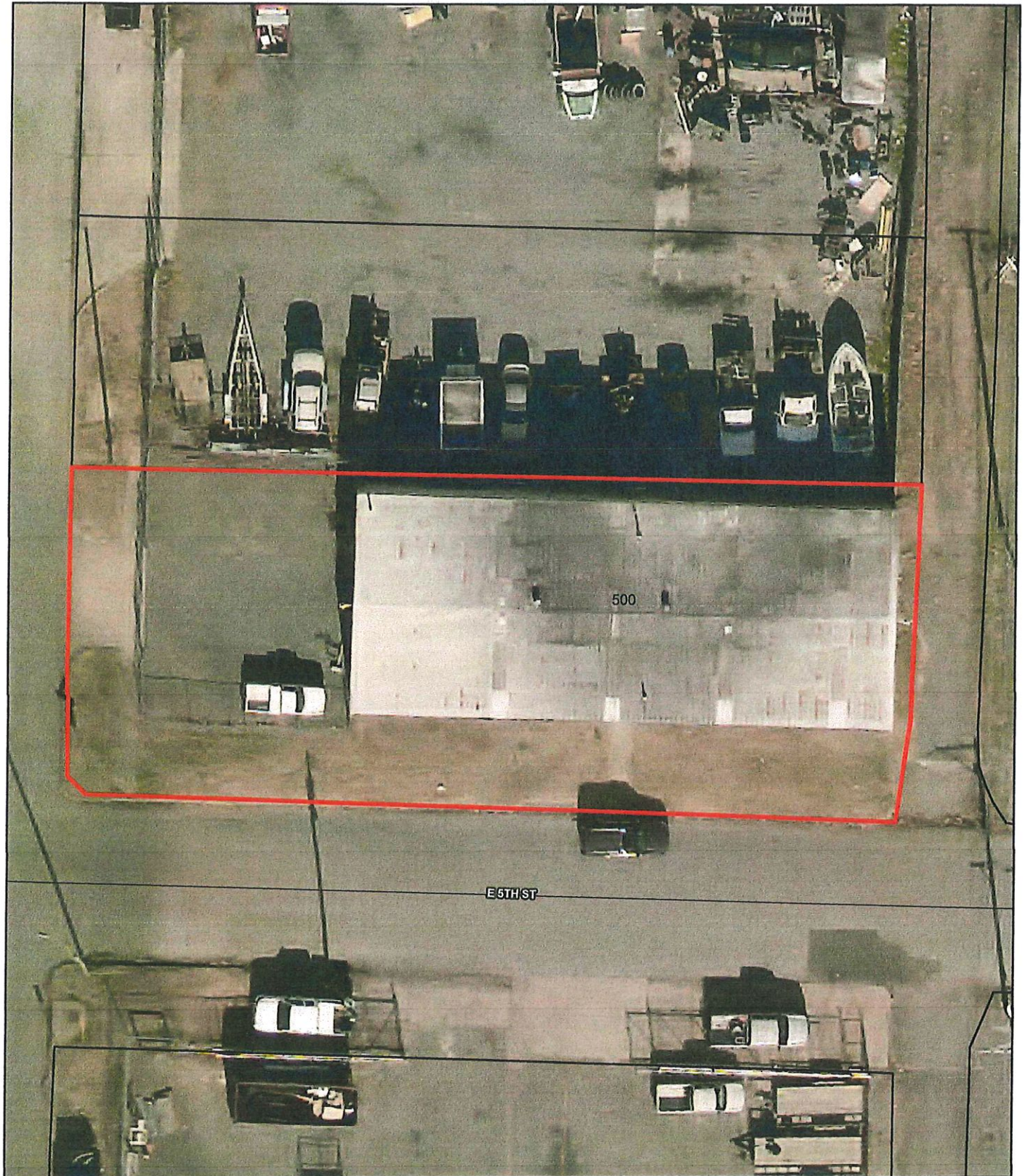

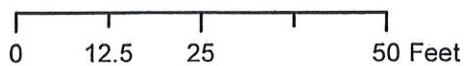
