**AN ORDINANCE AMENDING ORDINANCE NO. 9130 WHICH GRANTED A CONDITIONAL USE TO ALLOW A TIRE SHOP AND AN AUTO DETAIL BUSINESS IN A C-4 ZONE FOR PROPERTY LOCATED AT 923 EAST BROADWAY STREET IN THE CITY OF NORTH LITTLE ROCK, ARKANSAS; DECLARING AN EMERGENCY; AND FOR OTHER PURPOSES.**

WHEREAS, Ordinance No. 9130, adopted May 28, 2019, granted a conditional use to allow a tire shop and an auto detail business in a C-4 zone for property located at 923 East Broadway Street (See maps attached hereto collectively as Exhibit A); and

WHEREAS, the applicant is seeking approval from the North Little Rock City Council to amend the conditional use set out in Ordinance No. 9130 to update the business hours and to remove the requirement to add a curb to create entrance to the tire shop and auto detail business

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NORTH LITTLE ROCK, ARKANSAS:

SECTION 1: That Section 2 of Ordinance No. 9130 is hereby amended as follows:

Tire Store Conditions:

1. Hours of operation: ~~Midnight to 10:00 p.m.~~ 6:00 a.m. to 10:00 p.m.
2. Store tires in a dry securable area of the primary structure. No outside open-air storage of tires.
3. Up to 30 tires for sale may be displayed outside under a non-permeable cover during business hours. This is considered temporary tire storage. Tires shall be kept neat and organized, preferably in metal racks. Temporary outside displayed tires for sale shall be kept a maximum of 10 feet from the primary structure.
4. Isolate tires from other stored materials that may create hazardous products if there is a fire, including, but not limited to, lead acid batteries, fuel tanks, solvent barrels, and pesticide containers.
5. Store no more than 100 tires per 1,500 square feet of inside storage space.
6. Tire retailers should schedule regular pick-up of tires by a licensed carrier to avoid excessive amounts of tires stored on the property.
7. Vehicles are only to be repaired/maintained inside the building.
8. No auto repair other than those associated with removal/replacement of tires.
9. No outdoor PA/music permitted.
10. Provide 4 street trees.
- ~~11. Add curb to create one 30 ft. entrance to the site.~~
- ~~12.~~ 11. Allow two shipping containers as accessory structures in rear of property as shown on drawing. Accessory structure permits required. One shipping containers

not to exceed 40 ft x 8 ft x 8 ½ ft. & one shipping container not to exceed 20 ft x 8 ft x 8 ½ ft.

- ~~13.~~ 12. East side of the eastern most shipping container to have the appearance of the building.
- ~~14.~~ 13. Provide 60 ft buffer or opaque fence on NW property line beginning 60 ft off of E. Broadway.
- ~~15.~~ 14. Shipping containers not habitable.
- ~~16.~~ 15. Applicant must meet all applicable Federal, State, County and City requirements,
- ~~17.~~ 16. Business license to be issued after Planning Staff confirmation of requirements,
- ~~18.~~ 17. Applicant/owner understands that failure to comply with these conditions may result in loss of the Conditional Use and/or loss of Business License and/or removal of Electric Power Meter.

Auto Detail Conditions:

1. Hours of operation: ~~Midnight to 10:00 p.m.~~ 6:00 a.m. to 10:00 p.m.
2. A three chamber sand/oil interceptor is required. Please make submittal to North Little Rock Wastewater for review and approval.
3. Complete requirements of ADEQ.
4. All work to be done inside the building.
5. Provide 4 street trees.
- ~~6. Add curb to create one 30 ft. entrance to the site.~~
- ~~7.~~ 6. Applicant must meet all applicable Federal, State, County and City requirements,
- ~~8.~~ 7. Business license to be issued after Planning Staff confirmation of requirements, Applicant/owner understands that failure to comply with these conditions may result in loss of the Conditional Use and/or loss of Business License and/or removal of Electric Power Meter.

SECTION 2: That all ordinances or parts of ordinances in conflict herewith are hereby repealed to the extent of the conflict.

SECTION 3: That the provisions of this Ordinance are hereby declared to be severable and if any section, phrase or provision shall be declared or held invalid, such invalidity shall not affect the remainder of the sections, phrases or provisions.

SECTION 4: It is hereby found and determined that the approved hours of operation and removal of the requirement to add a curb to create a 30 foot entrance is compatible with other commercial development and businesses in the area, will not detract from other nearby businesses, and that the herein amendments to the conditional use of the above-described land is immediately necessary in order to insure the proper and orderly growth and development of this land and of the City of North Little Rock, Arkansas, and being necessary for the immediate preservation of the public health, safety and welfare, THEREFORE, an emergency is hereby declared to exist and this Ordinance shall be in full force and effect from and after its passage and approval.

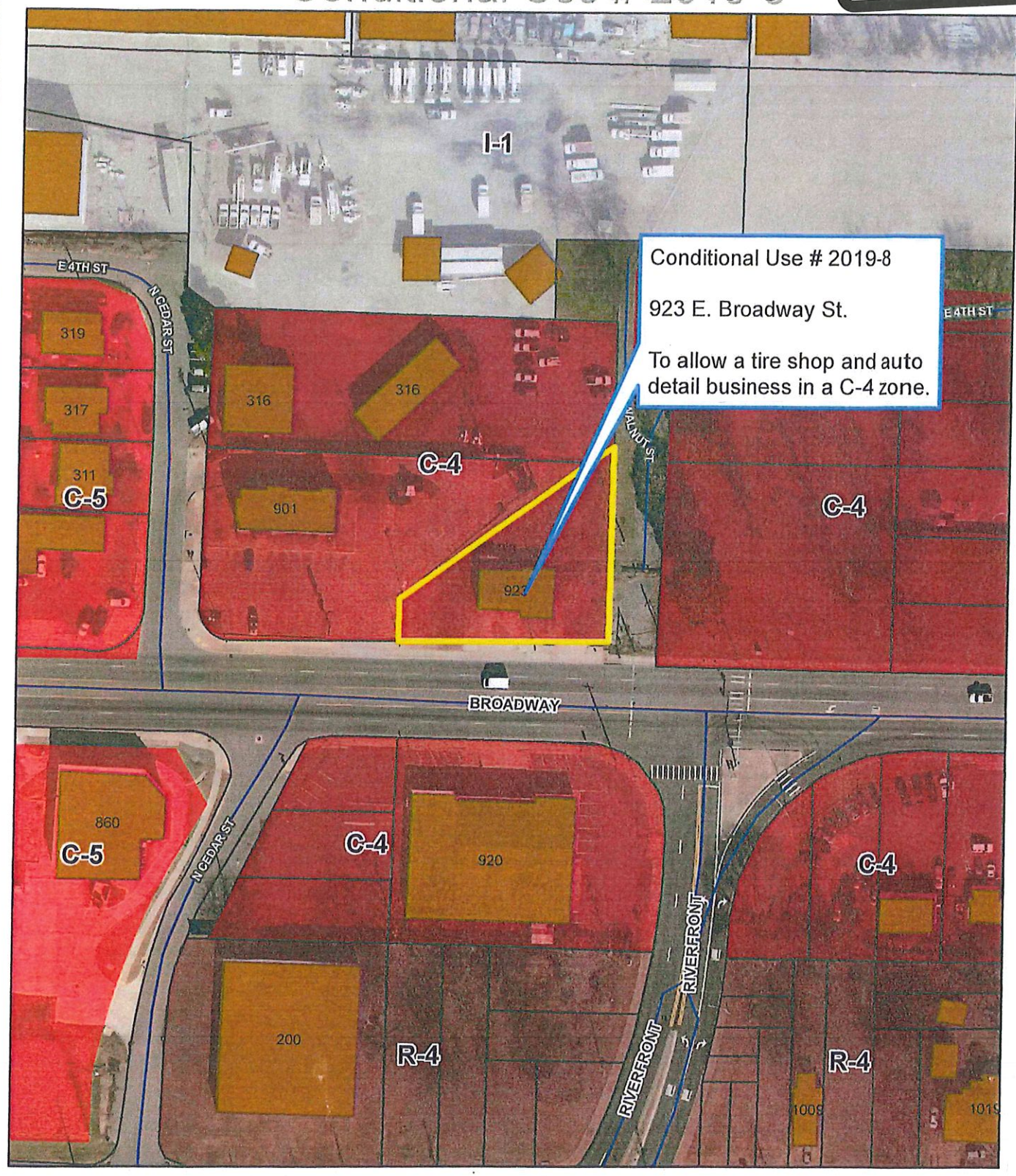

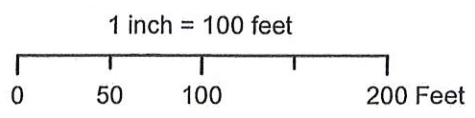

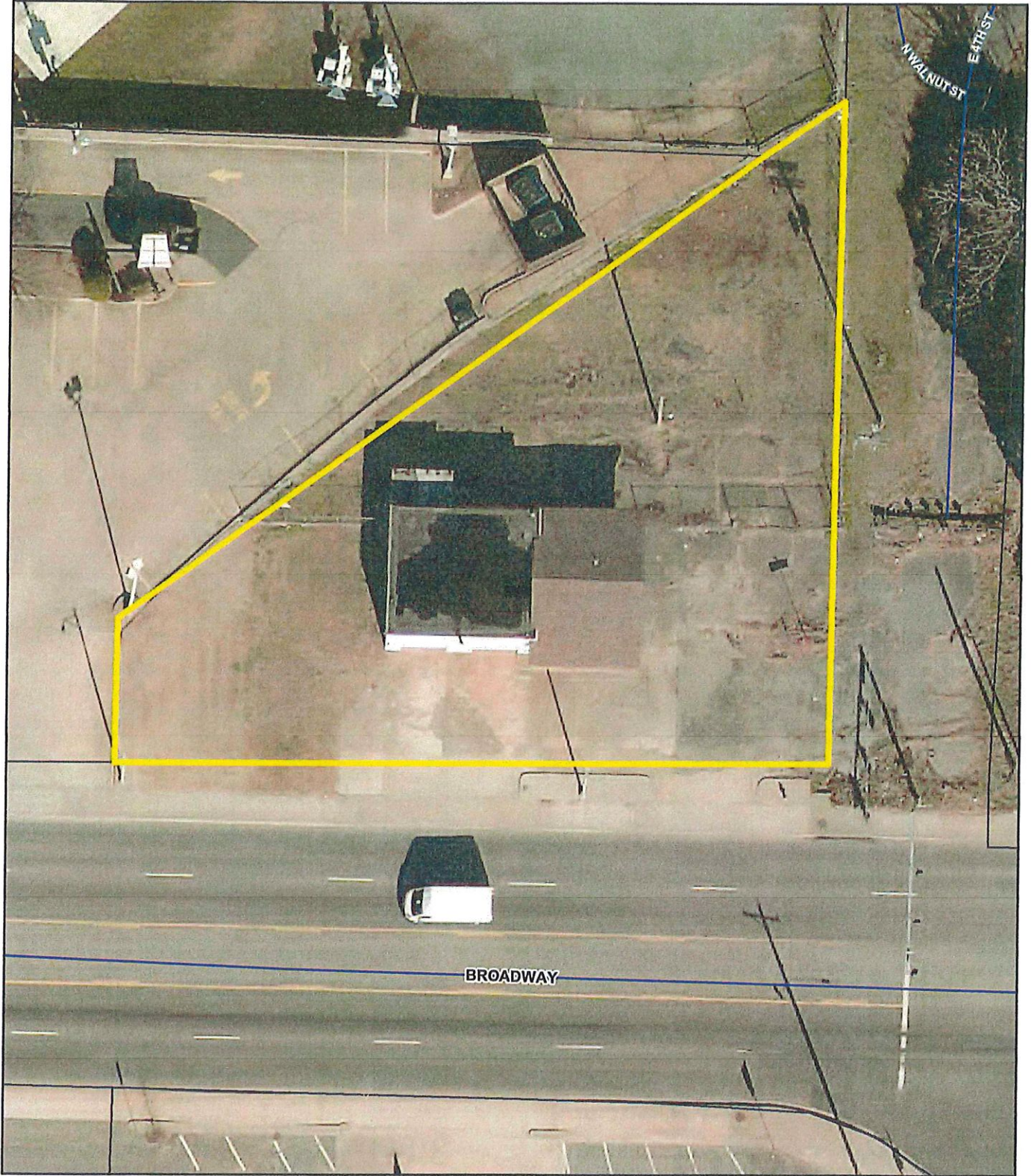


Conditional Use # 2019-8

To allow a tire shop and auto detail business in a C-4 zone.



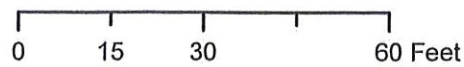


# Conditional Use # 2019-8
