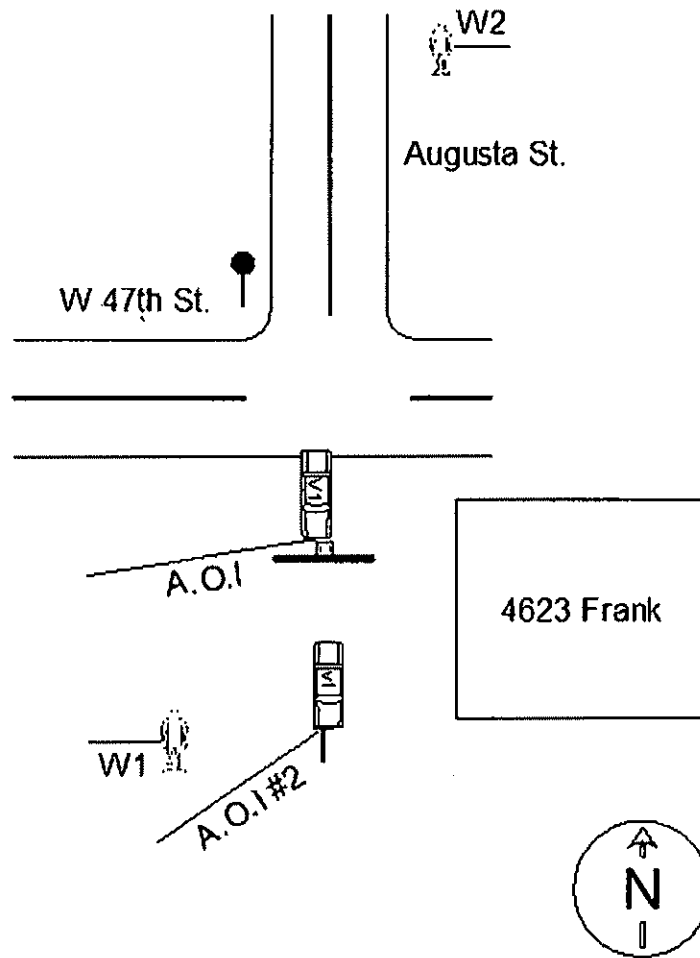

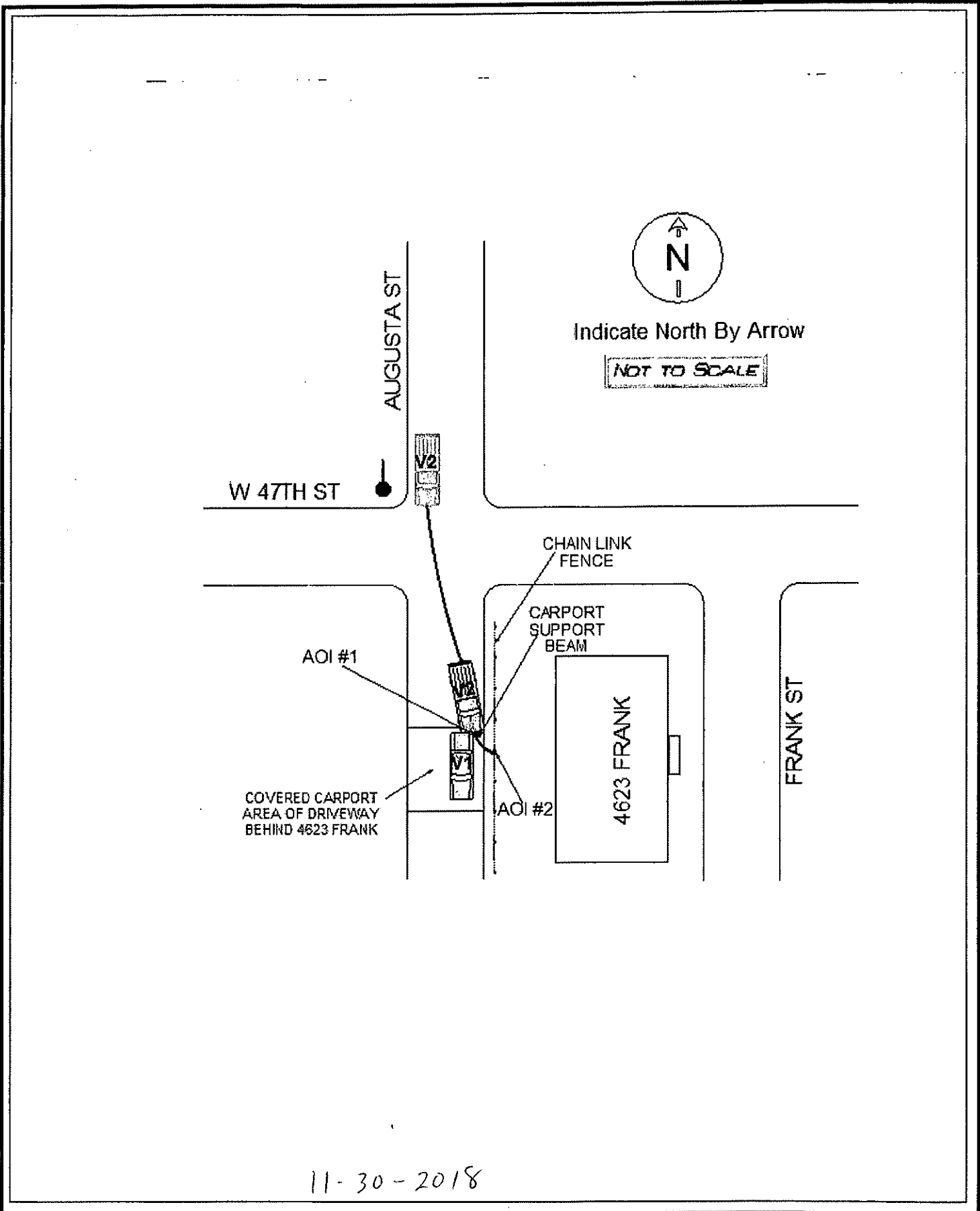


Indicate North By Arrow

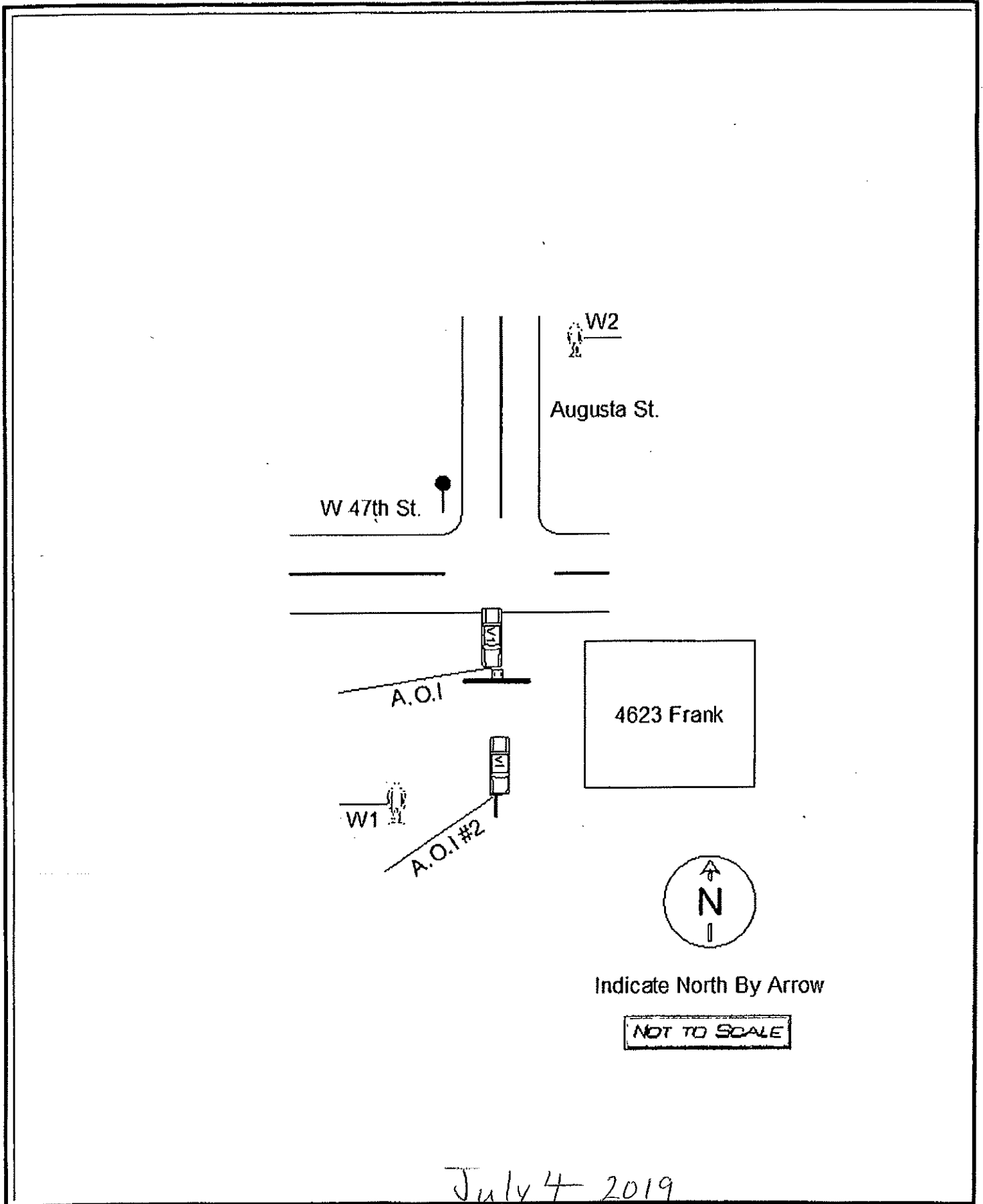
