A RESOLUTION EXTENDING THE CURRENT VOLUME DISCOUNT AGREEMENT WITH THE CITY OF LITTLE ROCK FOR CLASS I AND CLASS IV SOLID WASTE LANDFILL SERVICES: AND FOR OTHER PURPOSES.

WHEREAS, the City of Little Rock ("City of LR") owns Class I and Class IV landfills and responded to a request issued by the Pulaski County Regional Solid Waste Management District ("the District") for proposals for landfill services to be provided for household garbage collected from the City of North Little Rock ("the City" or "City of NLR") and other certain cities within the District; and

WHEREAS, the City of LR responded with its proposal and was notified on January 9, 2012 that its bid/proposal for the disposal of solid waste from the City had been accepted; and

WHEREAS, on March 26, 2012, Resolution No. 8031 was adopted authorizing the Mayor and City Clerk to enter into a Volume Discount Agreement with the City of LR for Class I and Class IV solid waste landfill services, the term of said agreement to run from April 2, 2012 thru April 1, 2017 with two (2) five-year mutually agreed upon renewals; and

WHEREAS, the City of LR proposes to extend the current Volume Discount Agreement with the City of NLR for another five-year term (thru April 1, 2022), continuing with the current tipping fee pricing of \$13.59 per ton and adding any current and state fees which are currently \$2.80 per ton (see extension authorization attached hereto as Exhibit "A"); and

WHEREAS, Ark. Code Ann. § 14-58-104(b) authorizes the governing body of a city to extend a contract, and it is in the best interests of the City and it residents that the agreement with the City of LR be extended another five years.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF NORTH LITTLE ROCK, ARKANSAS:

SECTION 1: That the Mayor is hereby authorized to execute the Extension Authorization between the City of NLR and the City of LR for Class I and Class IV Solid Waste landfill services (substantially similar to Exhibit "A" attached hereto), said extension to run through April 1, 2022.

SECTION 2: That this Resolution shall be in full force and effect from and after its passage and approval.

Dear Mayor Smith:

The City of Little Rock Solid Waste proposes to extend the current Solid Waste District Contract with the City of North Little Rock with adjustment that the City of Little Rock is no longer absorbing the district and state fees as part of the tipping fee bid price. The City of Little Rock proposes to continue the current tipping fee pricing and to adjust the fee to add any current district and state fees which are currently \$2.80 per ton. The proposed price will be extended for five (5) years and may be adjusted annually by the U.S. Implicit Price Deflator (IPD) for the U.S. Gross National Product, updated March 31 each year and published on the Arkansas Department of Environmental Quality (ADEQ) Solid Waste Division website. Below is a detail of the proposed fees.
