AN ORDINANCE AMENDING THE 2017 QUOTA ORDINANCE (ORDINANCE NO. 8871) FOR THE NORTH LITTLE ROCK ADMINISTRATION, FINANCE, PARKS & RECREATION AND POLICE DEPARTMENTS; DECLARING AN EMERGENCY; AND FOR OTHER PURPOSES.

WHEREAS, the City Council is responsible for establishing the number of employees in each department, and on December 27, 2016, adopted Ordinance No. 8871 establishing job classifications and numbers of employees for each department of the City of North Little Rock for 2017 (amended thereafter by Ordinance Nos. 8886, 8892 and 8929); and

WHEREAS, it has been determined by the City Council that it is necessary from time to time to amend such ordinance to add or delete positions, to correct errors, reorganize departments, reclassify positions, re-title positions, and for other purposes, to increase the efficient operation of the City of North Little Rock; and

WHEREAS, there is a need to add one position to the Administration Department, change the paygrade for one position in the Finance Department, add one position to the Parks & Recreation, and make a paygrade change for one position, add one position and delete one position (zero increase in positions) for the Police Department.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NORTH LITTLE ROCK, ARKANSAS:

SECTION 1: That Section 1 of Ordinance No. 8871, as amended by Ordinance Nos. 8886, 8892 and 8929, is hereby amended as follows:

SECTION 1: That the <u>Administration Department</u> shall consist of nine (9) elected officials and seven (7) eight (8) full time employees as follows:

Chief Information Technology Officer, NEG – 1, Add one position

Director of External Affairs, NEG – 1 Director of Special Projects, NEG – 1 Office Assistant, NEG – 1 Office Assistant III, NEG – 1 Special Assistant to the Mayor, NEG – 1 **SECTION 2:** That Section 14 of Ordinance No. 8871, as amended by Ordinance Nos. 8886, 8892 and 8929, is hereby amended as follows:
